I am directed to enclosed herewith true copies of two orders dated 06.11.2023 (copies enclosed) passed by the Tribunal (NLFT and ATTF) along with true copies of two show cause notices to be served on the NLFT and ATTF respectively, who are declared as "Unlawful Associations" vide notification No. S.O.4292(E) dated 03.10.2023.

- 2. The Hon'ble Tribunal vide its order dated 06.11.2023 has ordered to issue notice under Section 4(2) of the Unlawful Activities (Prevention) Act, 1967 to the NLFT and ATTF to show cause within thirty days from the date of service of the notice as to why the said association should not be declared unlawful and why order should not be made confirming the declaration under Section 3(1) of the Act. True copies of the show cause notices dated 06.11.2023 to be served on the NLFT and ATTF duly signed by the Registrar of the Tribunal is enclosed for ready reference.
- 3. The State Government of Tripura is requested to take necessary action, including taking into account the **eleven (11) methods** for serving the notice to both NLFT and ATTF, as directed by the Hon'ble Tribunal.
- 4. As stated in the Order dated 6-11-2023, the report of service of the notice to be submitted to the Registrar of the Tribunal in the office chamber of Joint Registrar (Vigilance), Gauhati High Court (New Block). 2<sup>nd</sup> Floor on 24.11.2023, duly supported by affidavits of the concerned officers(s)/officials(s), who have affected the service along with supporting document. Hence, action as ordered by the Tribunal may be completed and an action taken report on order of the Hon'ble Tribunal may be sent to MHA urgently. All documents and evidences of compliance of above orders is required for MHA affidavit as well as required to be mentioned in affidavit of State Government.

All updated copies of the FIRs related to unlawful activities committed by the NLFT and ATTF may also be sent to this Ministry urgently so that these could be reflected in the affidavit to be filed before the Tribunal.
- 6. Reference is also invited to this Ministry's letters of even no. dated 04.10.2023 and reminder 23.10.2023, documents/action taken in pursuance of this letter may also be sent to this Ministry to reflect the position in this service affidavit to be filed before the Tribunal.
- 7. The next date of hearing in the matter is on 15th December, 2023 at 04:30 PM.

A reference has been received by this Tribunal in terms of Section 4(1) of the Act.

On consideration of the material placed on record by the Central Government and after hearing Mr. S.C. Keyal, Ld. Special Counsel, Union of India, Mr. A. Chetia, Ld. Counsel for the State of Tripura and the representatives of the Department of Home, Government of Tripura, I am, prima facie, satisfied that notice under Section 4(2) of the Act should be issued to the aforesaid organization along with all their factions, wings and front organizations as well as that of their principal office bearers to show cause within thirty days from the date of service of the notice as to why they be not declared unlawful. Ordered accordingly.

का.आ. 4292(अ).—यतः नेशनल लिब्रेशन फ्रंट ऑफ त्रिपुरा तथा उसके अनेक स्कंधों (जिसे इसमें इसके पश्चात एनएलएफटी कहा गया है) तथा ऑल त्रिपुरा टाइगर फोर्स (जिसे इसमें इसके पश्चात एटीटीएफ कहा गया है) का स्पष्ट लक्ष्य, त्रिपुरा के अन्य सशस्त्र अलगाववादी संगठनों के सहयोग से और सशस्त्र संघर्ष के माध्यम से त्रिपुरा को भारत से अलग करके एक अलग राष्ट्र की स्थापना करना तथा ऐसे अलगाव के लिए त्रिपुरा के स्थानीय लोगों को भड़काना है;

और यत : , केंद्र सरकार का मत है कि एनएलएफटी और एटीटीएफ, -

- अपने लक्ष्यों को प्राप्त करने के लिए विद्रोही तथा हिंसक गतिविधियों में लिप्त रहे हैं और इस प्रकार ये सरकार के प्राधिकार को क्षति पहुंचाते रहे हैं और लोगों में डर एवं आतंक फैलाते रहे हैं;
- (ii) पूर्वोत्तर के अन्य विधिविरूद्ध संगठनों का समर्थन प्राप्त करने के उद्देश्य से उनसे घनिष्ठ संबंध बनाए हुए
- (iii) पिछले कुछ समय से अपने उद्देश्य एवं लक्ष्य की प्राप्ति के लिए, हिंसक तथा विधिविरूद्ध गतिविधियों में लिएत रहे हैं जो कि भारत की सम्प्रभृता तथा अखंडता के लिए हानिकर हैं;
- (iv) नागरिकों तथा पुलिस एवं सुरक्षा वलों के कार्मिकों की हत्या करते आए हैं;

And whereas, the Central Government is also of the opinion that the aforesaid activities of the NLFT and the ATTF are detrimental to the sovereignty and integrity of India and that they are unlawful associations;

And whereas, the Central Government is also of the opinion that if there is no immediate curb and control of the NLFT and the ATTF they will take the opportunity to, -

- (i) mobilise their cadres for escalating their secessionist, subversive, and violent activities;
- (ii) propagate anti-national activities in collusion with forces inimical to India's sovereignty and national integrity;
- (iii) indulge in killings of civilians and targeting of the Police and Security Forces personnel;
- (iv) procure and induct illegal arms and ammunitions from across the international border; and
- (v) extort and collect huge funds from the public for their unlawful activities;

Now, therefore, in exercise of the powers conferred by sub-section (1) of section 3 of the Unlawful Activities (Prevention) Act, 1967 (37 of 1967), (hereinafter referred to as the said Act) the Central Government hereby declares the National Liberation Front of Tripura (NLFT) along with all its factions, wings and front organisations and the All Tripura Tiger Force (ATTF) along with all its factions, wings and front organisations as unlawful associations;

The Central Government, having regard to the above circumstances, is of the further opinion that it is necessary to declare the NLFT and the ATTF along with all their factions, wings and front organisations as unlawful associations and accordingly, in exercise of the powers conferred by the proviso to sub-section (3) of section 3 of the said Act, the Central Government hereby directs that this notification shall, subject to any order that may be made under section 4 of the said Act, have effect from 3rd October, 2023 for a period of five years.
